<u>Illegal Dumping</u> by Truck Drivers. Be Aware: Truck drivers would come when property owners were not home & dump, or on vacant lots. Property owners need to be aware of Truck Drivers taking advantage of dumping their loads off. Non-Emergency Sheriff Reports will be needed to build a case against continuously illegal dumping of material.

***Per Attorney's advice, Property owners need to post "No Dumping" signs, & take pictures of this sign on their property (make sure picture clearly shows property owners land/address), if property owners should ever need to bring a lawsuit against these Truck Drivers illegal dumping on their land without permission, they will have this as evidence.
